# UIL Marching Band Update and Reminders 2023-24

### 1. 23-24 UIL C & CR Updates (Marching)

- Section 1106(h)(1),(2): AREA MARCHING BAND CONTEST. This amendment reduces the number of bands necessary to have a second round at the area contest from fourteen to ten.
- Section 1107(a): STATE MARCHING BAND CONTEST. This amendment changes the contest from an alternating-year format to an every-year format.
- Section 1107(g): STATE MARCHING BAND CONTEST. This amendment changes 4A bands from being evaluated utilizing the five-judge system to being evaluated utilizing the seven-judge system.
- 2. **Region Marching Band Statement of Compliance C&CR Section 1105**: To be submitted to the RES when the Region Marching Band Contest entry is completed and may be submitted electronically at the discretion of the region. <a href="https://www.uiltexas.org/files/music/Directors Compliance Update 2016.pdf">https://www.uiltexas.org/files/music/Directors Compliance Update 2016.pdf</a>
- 3. **Region Marching Band Contest Entry on TX Music Forms:** Requires that an intent to advance be declared, as well as declaring either open class or military class. Area contests will be held for all conferences. Note: no band may participate in both the military and open class state contest in the same year. Any band declaring military track may not participate in the area contest.
- 4. The Marching Band Rules Advisory Committee is recommending that Competition Suite be used for Marching Comments at the Region level. I am in the process of studying this recommendation including the financial implications.
- 5. **Marching Band Director Safety Training:** State Law requires that everyone teaching marching band annually complete a safety training course (Everyone who is teaching students). - 6. Marching Band Physical Exams are required by UIL prior to any physical activity. Athletic and Marching Band Pre-participation Physical Evaluation University Interscholastic League (UIL) (uiltexas.org)
- 7. Marching Band Contest Inclement Weather Plans and Date: Each Region and Area is to follow local ground rules for events held at a venue. Each Region and Area is to have an inclement weather date in the event the contest must be rescheduled. Judge arrangements for any inclement date should also be made in advance.

### 8. Wireless Frequencies at Marching Band Contests:

- The RES and the contest host should make every effort possible to ensure non-essential wireless frequencies in a venue are turned off and any active frequencies are communicated to the participating bands in advance of the contest. There will be no "restarts", "delays" or "do overs" due to any issue related to electronics.
- Beginning in 2022, the UIL marching band rules advisory committee passed a proposal allowing bands at a contest to check wireless devices only during contest intermissions and during the 7- minute period that includes a band's 2-minute field exit and a band's 5-minute field entrance. This includes bands in warm-up and other areas around the stadium. This information should be included in the contest procedures for every region and area contest. This includes no wireless microphones or metronomes in the warm-up areas.
- Athletic and Marching Band Pre-participation Physical Evaluation University Interscholastic League (UIL)
   (uiltexas.org)At the stadiums at Waller ISD and CFISD, the wireless is turned off for marching contest.
   Thus, you will not see any wireless frequencies in the contest packet. However, you should make sure you have that information when you go to other stadiums.
- 9. For consistency at every round of competition the UIL marching band rules advisory committee passed a proposal that UIL make every effort to have a standardized region/area/state contest schedule matrix to include a 45- minute warm-up period.
- 10. Marching Band Video Educational Use Agreement: Once annually, schools participating in UIL marching band contests wishing to make an educational use video of their performance at a UIL contest are to complete the Educational Use Agreement found on the state website. The contest host should designate an area for videographers at each contest venue. - 11. **Adjudication Rubrics:** Each region will distribute and emphasize use of rubrics at all marching band contests and concert and sight-reading evaluations. All rubrics are to be taken from www.uiltexas.org/music to ensure the most current versions are being used. Note that the region marching band rubric is included on the back of the adjudication sheet.

#### 12. 22-23 C&CR Updates (Reminders)

- Section 1105 (h)(5)(A): Electronics cables may now cross the sidelines. Students may NOT perform over cables that are on the field, whether they are covered or not.
- Section 1105 (h)(5)(B): A non-student may intervene during the 8-minute performance clock to address an electronics failure. The school must supply the contest chair with a written justification for doing so. If the RES and contest chair determine that the justification does not support the action, the REC may proceed with consideration of penalty.
